- If you want to intervene and oppose the adoption, file a motion to intervene with this court within 30 days after the Notice of Petition to Adopt was served on you.

- (2) I am the adoptee. I am over the age of 12, and I have the mental capacity to give consent.
- (3) I understand that if I am adopted, my non-custodial parent will not have any parental rights or responsibilities for me.
- (4) I understand that if I am adopted, my custodial parent will continue to have full parental rights and responsibilities for me.
- (5) I understand that if I am adopted, the adopting parent will be known as my parent and I will be known as his or her child. I understand that I may take his or her family name.
- (6) Understanding all of this, I voluntarily waive my right to be notified of hearings and served with papers in this matter, and I voluntarily waive my right to intervene in this matter.
- (7) Understanding all of this, I voluntarily consent to be adopted.
